





Our Services

Import and Export Services

Masazie in partnership with the local and international farmers supply and distribute a wide range of superior agricultural products such as Edible & Non Edible Oils, Dairy Products, seeds, spices, nuts, grains, sugar, maize, canned food, fruits and vegetable products. The company has built up a wealth of experience in agricultural products business and has developed strong mutual beneficial relationships with customers all over the world.

The future plan is to have a factory covering an area of 90, 996 square meters, with 4 warehouses equipped with complete automatic sun floor plants along with packing and filling machines. We are one of the private entity with import and export registrations with South African Revenue Services. We also plan to be one of the biggest manufacturers which are producing and processing agricultural products. In recent years, depending on the stable products quality and reliable supply, we have gained a prestige for our clients.

Import Services and Import Shipping

All merchandise coming into the South Africa must be cleared through RSA Customs and Border Protection and is subject to Customs duty, unless specifically exempted by law. Clearance involves a number of steps, which include inspection and appraisement.

Import shipping and customs law requires that duty be paid on goods entering the county, according to its official classification from a tariff schedule. Sometimes a surety bond is required, and some types of goods must meet admissibility standards, with proper permits secured in advance by the importer.

Logistics and Transport Services

Masazie Holdings has created a subsidiary of transport and logistics called Masazie Logistics to handle a bulk, palletes and containers of commodities such as Chrome, Coal, Coke, Fertiliser, lubricants, Magnetite, Manganese, Steel, Grain, Rice, Sugar, Tiles, and Wheat.

We have a dedicated contract management team who oversee operations proficiently from 24/7 control rooms, boosting the latest in satellite tracking and fleet and planing tools.


